The Administrator seeks to recover unpaid minimum wages and overtime compensation on behalf of the employees of this bank from the defendant trust company for the years above stated. The respondent has moved to dismiss the petition on the ground of a lack of jurisdiction, and that the petition fails to state facts sufficient to constitute a cause of action. Respondent has not directly answered the petition, although it has filed a "Motion to Dismiss" and its memorandum in support thereof, denying jurisdiction.
